**LETTER OF AGREEMENT
COMPENSATION OF EMPLOYEES
SHELBY COUNTY, TENNESSEE**

Pursuant to Tennessee Code Annotated, Section 8-20-101, this agreement by and between

Shelby County Clerk & Master Dewun R. Settle and Shelby County Mayor AC Wharton
(Official/Office)

is for the purpose of establishing the number of employees and the authorized salaries for Chancery Court.
(Office)

The parties named herein have agreed and do hereby enter into this agreement according to the provisions set forth herein:

- A. The term of this agreement will be from July 1, 2008 to June 30, 2009.
- B. In order to ensure the efficient operation of the office, it is agreed that the official is authorized to employ the following employees at salaries not to exceed the specified amounts:

- C. It is further agreed that part time help may be employed at an entry rate of the position with a total cost not to exceed \$ 12.61 per hour for the term of this agreement.
- D. The parties agree to the following special provisions:
To pay such sums that might be required for premiums on hospitalization insurance, FICA payments, life insurance and contributions to the Pension and Retirement System of Shelby County, for the benefit of his employees.
Employees hired on after April 1, 1986 will be required to contribute to Medicare and official shall pay the County's share of the salary of each employee in his office who is required to make such Medicare payments.
- E. If it is further agreed that in no event shall the amount of this agreement exceed \$389,131.00.
