T.C.A. 22-1-101

It is the policy of this state that all qualified citizens have an obligation to serve on petit juries or grand juries when summoned by the courts of this state, unless excused. If you are eighteen (18) years of age or older, a citizen of the U.S. and have been a resident of Shelby County for the past twelve (12) months you are qualified to act as a grand or petit juror, unless otherwise incompetent under T.C.A. 22-1-102. If you are not qualified because of age or resident, a copy of driver license may be mailed, faxed to 901-222-1651 or emailed to jurycommission@shelbycountyttn.gov. If you are not a citizen, mail, fax or email a copy of your Visa, green card, or permanent resident card.

If you have been convicted of a felony or other infamous offenses, or if you have been convicted of perjury or subornation of perjury, you cannot act as a grand or petit juror. Documentation may be mailed, faxed to 901-222-1651 or emailed to jurycommission@shelbycountyttn.gov

T.C.A. 22-1-103 (a)

A juror may be excused from serving if prospective juror has a mental or physical condition that may cause one to be incapable of performing jury service. Juror must provide the court with documentation from a physician licensed to practice medicine, verifying the person is unfit for jury service. Documentation may be mailed, faxed to 901-222-1651 or emailed to jurycommission@shelbycountyttn.gov

IT IS THE DUTY OF THE JUROR TO CALL THE JURY COMMISSION TO VERIFY DOCUMENTATION HAS BEEN RECEIVED AND PROCESSED, PRIOR TO THE DATE OF APPEARANCE.

T.C.A. 22-1-103 (b)

A juror may be excused from serving upon showing to the court that juror's service will constitute an undue or extreme physical or financial hardship to the prospective juror or a person under the prospective juror's care. To be excused under this section, you **MUST APPEAR** and submit documents such as tax returns, medical statements, proof of dependency or guardianship, or other documentation that may assist the judge in making a decision.
